

ABPath IN THE NEWS

The National Cancer Policy Forum hosted the National Academies of Sciences, Engineering, and Medicine's workshop "Improving Cancer Diagnosis and Care: Patient Access to Oncologic Imaging and Pathology Expertise and Technologies" in Washington, DC this past February.

The workshop highlighted current diagnostic challenges and opportunities to expand patient access to diagnostic expertise and technologies in cancer care. As a part of the workshop, participants discussed efforts to move toward a more continuous process of learning and assessment of clinical knowledge, judgment, and skills based on the rapid advancements of new knowledge in medicine. ABPath was recognized as being receptive to pilot programs and progressive in our approach to measuring competency of physicians, including the longitudinal assessment pilot through ABPath CertLink®. 2018 BOARD ACTIONS

- ABPath is now the official acronym for the American Board of Pathology.
 ABP will no longer be used to represent the American Board of Pathology, eliminating confusion with the American Board of Pediatrics.
- ABPath has changed the name of Maintenance of Certification (MOC) to Continuing Certification (CC) in order to align with ABMS messaging.
- ABPath updated its fetal autopsy requirements for primary certification;
 see the ABPath Booklet of Information at www.abpath.org.
- The Society for Hematopathology and the Society for Pediatric Pathology are new Cooperating Societies of the ABPath.
- ABPath will allow a 5-year period to take and pass the initial certification exam from the year certification lapsed/expired, due to not passing the CC exam during the 10-year CC cycle and not passing the exam during the one-year post cycle grace period. The exam can be taken as many times as it is offered in that 5-year period.
- ABPath will not require a diplomate with primary certification by another ABMS board to maintain that certification in order to maintain ABPath subspecialty certification; they must meet ABPath Continuing Certification (CC) requirements to maintain the subspecialty certification.

 In 2019, diplomates who no longer practice pathology and no longer have a current medical license will have their certifications reported as 'Retired' status.

In 2019, ABPath will adopt a new mission, vision and values.

NEW ASSESSMENT INITIATIVE— ABPath CertLink®

2018 has been an exciting year with the launch of the ABPath CertLink® pilot in July. The online longitudinal assessment platform is being continually refined with added features and benefits. Over five thousand of our diplomates are currently participating and enrollment is steadily growing as the word gets out.

The ABPath CertLink Pilot was developed through a partnership with the American Board of Medical Specialties to enhance the CC Part III experience for diplomates, while also establishing that it is a reliable and valid assessment for making summative decisions about medical knowledge, judgment, and skills. Through CertLink, participants answer questions, many with images, using a web browser. Once answered, diplomates receive immediate feedback whether they answered the question correctly or incorrectly, a short narrative about the topic (critique), and references. They are also able to provide feedback on each individual item. Participants have a personalized dashboard which summarizes their ongoing performance and identifies their knowledge gaps. Participants in the pilot have given extremely positive feedback, with increased enrollment each quarter. ABPath CertLink is expected to be an eventual alternative to the current 10-year CC examination.




CertLink® Updates

New CertLink® Mobile App

The ABPath CertLink® mobile app is now available for download on tablets through Google Play (Android) and Apple (iPad) App Stores, making this platform even more accessible and easy to integrate into physicians' daily practice workflow.

Answering Questions

The number of questions for participants to answer each quarter (quarter=3 months) has been reduced from 20 to 15 in 2019.

Time-Off

ABPath Administrators have a feature to allow time-off from ABPath CertLink participation for a diplomate with an approved hardship. A diplomate may request to take 1-2 quarters off during each 2-year reporting period of the ABPath CertLink Continuing Certification program. Diplomates are also able to cancel time-off in any current or future quarter. Contact ABPath to elect or cancel time-off.

The next segment will begin **January 2, 2019.** (*Registration has closed for this segment.*) The following segment starts **July 1, 2019.** Registration is open now until May 13, 2019.

CME CREDIT FOR ABPath CERTLINK®

The American Board of Pathology and the American Society for Clinical Pathology Announce an Opportunity to Earn CME/SAM Credits for Participating in ABPath CertLink

The American Board of Pathology (ABPath) and the American Society for Clinical Pathology (ASCP) are pleased to announce a partnership to award Continuing Medical Education (CME/SAM) credits to participants in ABPath CertLink®, an innovative assessment program that drives physician professional development. ABPath has selected ASCP, a leading educational provider for pathologists, as the accredited ACCME provider. ASCP will enter into a joint providership agreement with ABPath to award diplomates AMA PRA Category 1 Credit™ for self-assessment for participating in the ABPath CertLink program. The two organizations believe that assuring that pathologists maintain continuing competence includes participation in Continuing Certification (CC, formerly known as MOC) and completing relevant CME/SAM.

"It is important that Continuing Certification is relevant to our physicians' practice and ABPath CertLink is proving to be an effective means for physician self-assessment," states Rebecca L. Johnson, CEO of the American Board of Pathology. "We are so pleased to work with ASCP to provide CME/SAM and greater value to our diplomates for this activity."

ABPath CertLink meets ACCME requirements for continuing medical education with assessment. In response to feedback from our diplomates, ABPath wanted participating physicians to have the opportunity to receive CME credits. Through this partnership, ASCP will award 5 AMA PRA Category 1 Credits™ each year (1.25 credits/quarter) to diplomates participating in ABPath CertLink. These credits will be available in the first quarter of 2019.

ASCP has been reviewed by the Accreditation Council for Continuing Medical Education (ACCME) and awarded Accreditation with Commendation for six years as a provider of continuing medical education (CME) for physicians. This achievement has placed ASCP in the highest tier of all continuing medical education (CME) providers. Accreditation in the ACCME System seeks to assure the medical community and the public that ASCP delivers education that is relevant to clinicians' needs, evidence-based, evaluated for its effectiveness, and independent of commercial influence.



In 2018, ABPath began the process of changing its Maintenance of Certification (MOC) Program to be called the Continuing Certification (CC) Program. For the American Board of Pathology, this change is more than a superficial name change. Continuing Certification should be the embodiment of a modern and responsive continuing certification process. Since 2015, ABPath has issued certificates without expiration dates; certification will remain valid as long as a diplomate meets the requirements of Continuing Certification. In the past few years, ABPath has implemented new initiatives to facilitate diplomate participation in the CC program:



- Diplomate access to ACCME CME Finder for search and selection of relevant CME
- Automated reporting of CME/SAM credits via ACCME PARS starting in 2019
- Additional patient safety courses to meet PSC requirements
- Changes to the Continuing Certification examination to increase practice relevance, including the use of books and notes during the exam and remote testing.

It is the ABPath's transition towards longitudinal assessment via ABPath CertLink® that also supports the name change. The ability to continuously assess a diplomate's knowledge, provide immediate feedback, and identify relevant educational gaps while also providing access to resources via CME Finder to address those gaps provides diplomates an ongoing process to increase their knowledge and continue their certification. The concept of "continuing certification" is key as certifications should no longer be thought of in terms of something to "maintain", but rather a sign of a pathologist's continuing advancement for both their career and the field of pathology. Board certification is the standard recognized by physicians, the public, and credentialers and Continuing Certification is the way certification and the knowledge it represents can continue to be that standard.

While ABPath has made great progress towards our vision of Continuing Certification, there are still changes and progress which need to be made. ABPath CertLink, for example, is still in a beta development phase. The board appreciates the understanding and patience from diplomates and looks forward to the continuing spirit of cooperation as updates to the CC Program are made in 2019 and beyond.






INQUIRING MINDS WANT TO KNOW

Top 10 Certificate Combinations in Continuing Certification




CC Exam Breakdown

Forty-eight percent of all CC Part III examinations ever taken are combined examinations, meaning the examination covers both primary and subspecialty certification. CY and HE continue to be the most frequent subspecialty examinations. These two certifications account for sixty-two percent of all combined examinations and fifty-five percent of all subspecialty only examinations.


CC Exam Breakdown




Primary Exams Only

FOCUSED PRACTICE DESIGNATIONS

The American Board of Pathology (ABPath) is pleased to announce our two new Focused Practice Designations (FPD) in Clinical Chemistry and Clinical Microbiology. The purpose of these two designations is to recognize and provide a credential to diplomates who have successfully completed training in a Commission on Accreditation in Clinical Chemistry (ComACC) or in an American Society for Microbiology Committee on Postgraduate Education Programs (CPEP) accredited training program. These designations will also be available to recognize ABPath certified physicians whose practice has been primarily or exclusively devoted to either of these two areas. These are not new areas of certification, but rather designations. The ABPath will continue to offer subspecialty certification in Chemical Pathology and Medical Microbiology to diplomates who have completed ACGME accredited training in these specialties.


All the information, requirements, and applications for the designations are available on the ABPath website (www.abpath.org). 2019 applications are due by July 19, 2019. Secure exams will be administered remotely during a two-week period in September, dates to be announced.

ABPath FEES

ABPath is often asked how our fees compare with other ABMS Boards. Recently ABMS did a data analysis comparing member boards. We are pleased to report that we are the lowest of the 24-member boards for operating revenue per diplomate, operating revenue per certificate issued, operating expense per diplomate, and operating expense per certificate issued. Our certification fee ranks at the 30th percentile of all ABMS member boards and the fees have not increased since 2003 even with the added services to our diplomates—ACCME PARS and ABPath CertLink®. The ABPath CC fees are among the lowest of all ABMS member boards, at \$1200, including the exam, over ten years. The most expensive board has 10-year CC fees of \$5,230.

ACCME PROGRAM AND ACTIVITY REPORTING SYSTEM (PARS)

The American Board of Pathology (ABPath) has partnered with the Accreditation Council for Continuing Medical Education (ACCME) to create an automated process for reporting of a pathologist's AMA PRA Category I CME (including SAMs) to the ABPath for our Continuing Certification Program. The ACCME Program and Activity Reporting System (PARS) is now active and provides tracking of completed CMEs in a diplomate's PATHway account.

Once a CME activity is completed, with a pathologist's permission and their ABPath ID#, an accredited CME provider that is participating in PARS will report this information to ACCME, which is then sent on to ABPath. The CME credits will automatically show in the diplomate's CC reporting form in PATHway, beginning with 2019 CC reporting forms, and a transcript of CME credits reported via PARS will be available for download. Diplomates will still have the ability to manually enter CME activities from providers not participating in PARS. American Society for Clinical Pathology

(ASCP), College of American Pathologists (CAP), and United States and Canadian Academy of Pathology (USCAP) are currently participating in PARS and we expect other CME providers will participate in the future.

As an additional benefit of this partnership, diplomates will now be able to search for CME activities by credit type (CME, SAM, and Improvement in Medical Practice [Part IV]), provider, and key word in ACCME's **CME Finder** (http://www.cmefinder.org/).

This streamlined process has been developed for our diplomates' benefit through the joint commitment that

ABPath and the ACCME share to support pathologists' continuing professional development and to improving pathologists' performance for the care of patients.

Please Note: For automatic reporting of completed CME to ABPath, diplomates will be required to provide their ABPath ID# to CME providers. Your ABPath ID# can be found in PATHway on your profile page, top left corner.



ABMS CONTINUING CERTIFICATION DIRECTORY

The American Board of Medical Specialties (ABMS) offers a centralized repository of approved MOC activities relevant to multiple medical specialties and subspecialties. Physicians can access approved CME activities for MOC categorized by ABMS specialty/subspecialty or by ABMS-ACGME competency. CME providers can submit and receive approval to list their CME offerings in the directory. This directory increases the inventory of MOC CME activities for diplomates and identifies activities that may be relevant to more than one specialty. CONTINUING CERTIFICATION: VISION FOR THE FUTURE COMMISSION

The Continuing Board Certification: Vision for the Future Commission has released its draft report for public comment. The report, which includes the Commission's key findings and recommendations, is posted on the Vision Initiative website at https://visioninitiative.org/.

In creating the draft report, the Commission considered the input received from key stakeholders reflected in the more than 21 hours of testimony and results of the open stakeholder survey posted this past summer on its website. The report outlines the Commission's findings and a set of recommendations for future continuing certification pro-

grams. The Commission will meet one last time to review and discuss the comments received and make revisions to the draft before submitting its final report to the Board of Directors of the American Board of Medical Specialties in February, 2019.

Our patients want the best care for themselves and their families. They believe Board Certification is an important factor when choosing a physician. In fact, more than four out of five people surveyed say a doctor's certification status is an important factor for choosing a doctor—second only to whether the doctor is covered by their insurance. For patients, knowing that the physicians who treat them and

their family members are Board Certified instills peace of mind and confidence, especially at a time when they may be worried or upset.

To help patients find out if a physician they're considering is Board Certified, and to educate consumers about the value of board certification, the American Board of Medical Specialties has redesigned the *Certification-Matters.org* website. This free public service is now mobile-friendly and features a simplified search tool, as well as information about the American Board of Pathology (ABPath) and the other specialty boards that certify physicians. Certification Matters provides information in consumer-oriented language about what it means to be a Board-Certified physician.

Our diplomates are skilled and knowledgeable experts in their specialty, having met a higher standard by choosing to be Board Certified. We want our patients to know this, and the Certification Matters website will do that.



IMPROVED EXAM RESULT TURNAROUND TIMES

This year ABPath saw a marked improvement in turnaround time for the release of exam results. We are pleased to report, the Fall 2018 Primary AP/CP and the Blood Banking Transfusion (BB/TM) exam results were posted almost a month earlier than in 2017. Much of this year's significant change is due to the addition of an in-house psychometrician, Dr. Aaron Douglas. Dr. Douglas came to ABPath with over 15 years of experience as a scientist in standardized testing and has worked diligently to streamline our methods and expedite the reporting of results.

In the past, ABPath has used an outside vendor for scoring exams and with the exception of the Continuing Certification exam, we now score all of the exams in house. We expect the turnaround time to continue to improve as we improve our processes.



EXAMINATION ADMINISTRATION HISTORY

As science advances and the field of pathology evolves, ABPath continues to serve the profession of pathology with the most relevant and meaningful assessments. Here is a look at when we began offering each primary and subspecialty certification and how many certificates have been issued from inception through 2018.

CERTIFYING EXAMINATION PROGRAM AND CANDIDATE PERFORMANCE REPORTS

Program Performance Reports will be available to Program Directors in Resident Tracking in early 2019. The ABPath annually generates Program Performance Reports for each ACGME accredited primary and subspecialty training program. The report now provides more detailed exam content performance data. Subspecialty program performance reports are only provided if there are at least three fellows in the program during the past five years, in order to maintain candidate confidentiality. The program performance data (not individual candidate performance) is provided annually to the ACGME Review Committee for Pathology as part of the Next Accreditation System.

Performance reports provided to unsuccessful candidates now also provide more detailed exam content performance data. This should be useful to candidates to identify areas of weakness.

The feedback includes:

Reference based performance—how the candidate did as compared to others who took that exam in the same sitting; reported in tritiles—upper, middle, lower.

Criterion based performance—how the candidate did compared to a criterion of 50%; reported as either "good" (more than 50% of items in that category were answered correctly) or "low" (less than 50% of the items in that category were answered correctly). A candidate could theoretically be "good" but "low" if two-thirds of candidates scored better in that category (easy questions) or a candidate could be "low" but "upper" (difficult questions).



EXAM BLUEPRINTS

The primary and subspecialty examination blueprints (grids) are posted on the ABPath Website. The blueprints give categories of topics covered in the examinations with the approximate percentage of questions for each topic.



HONOR CODE

The Board has an honor code statement that must be signed by applicants and registrants for ABPath certification exams. We are aware that in the past residents and fellows have used recalled items to prepare for Board exams. The ABPath considers this practice to be cheating, unethical and unprofessional behavior. Program Directors are encouraged to talk with their residents about the honor code, professionalism, and ethical behavior.

EXAMINATION PERFORMANCE

All of the ABPath examinations are graded using the criterion-referenced method. Visit the ABPath Website for examination information. The number of candidates passing the examinations does not match the number of candidates certified for several reasons: (1) Some AP/CP candidates, both first-time takers and repeaters, take only one portion (either AP or CP) of the examination. These candidates are not certified until both AP and CP are passed. (2) Certified candidates include AP/CP candidates who passed either the AP or CP examination previously and requested single certification during the reporting year. (3) Certified candidates also include AP/CP candidates who passed the examinations in a previous year, but did not provide documentation of licensure or other required information until the reporting year.
